How your expense claims are processed

As soon as we receive your Expense Claim form and receipts we will check that your claims are allowable. Once they have been approved, any mileage claims will be offset immediately (assuming your mileage claims are for work done when you are not under SDC or your mileage claims are for client to client journeys) and these will be used in subsequent pay runs in order to reduce your Tax and NI liabilities. All other expenses you submit will be recorded for you and a report will be sent to you at the end of the tax year for you to submit via a Form P87 or as part of a self-assessment.
